

Gingerstips.com. understands that you care about your personal information and how it is used. Therefore, we are committed to protecting the privacy rights of guests of www.Gingersips.

This policy covers how Gingerstips.com (“Gingerstips”) treats personal information that GINGERSTIPS collects and receives through www.Gingerstips.org and additional websites, mobile sites or applications that we may own or operate in the future or any website, mobile site or application operated by a third party on which any content or promotion we sponsor that expressly adopt, and display or link to this Privacy Policy (collectively referred to as the “Sites”). This policy does not apply to the practices of third parties that GINGERSTIPS does not own, control, manage or employ.

By accessing, browsing or otherwise using the Sites, you confirm that you have read, understood and agree to this privacy policy.

COLLECTING INFORMATION

The information we obtain from you helps us personalize and continually improve your shopping experience on the Sites. Any personal information you provide to us is maintained on secure servers and internal systems. It is always your choice whether or not to provide personal

information. Any information you provide will be treated with care, and subject to this Policy, will not be used or disclosed in ways to which you have not consented.

GINGERSTIPS collects personal information when you establish or update a GINGERSTIPS account, participate in a survey, quiz or poll, shop online, enter a contest or promotion, check the status of an order or review order history, join our mailing list, follow our brands on social networking sites, purchase and send a gift card, post reviews or contribute comments. During your use of the Sites, you may be asked to voluntarily disclose personal information including your name, email address, birth date, zip code, occupation, industry, and how you heard about us. Once you make a purchase with GINGERSTIPS or an affiliated site, GINGERSTIPS will require your payment, shipping and billing information and will maintain order history for ease of future purchases.

You can edit your GINGERSTIPS account information at any time. GINGERSTIPS will automatically send you certain communications relating to the GINGERSTIPS service, such as service announcements, administrative messages and the GINGERSTIPS Newsletter, that are

considered part of your GINGERSTIPS account. However, if you do not wish to receive e-mail or other mail from GINGERSTIPS, you can unsubscribe at any time.

To Unsubscribe – simply follow the instructions included in every email.

GINGERSTIPS collects navigational information about where our guests visit on the Sites and information about the technical operation of the Sites and services. This information helps us better understand our guests' experience during their visit allowing us to improve the quality of a guests' online experiences. Information about your mobile device, computer or other device (for example domain, browser, service provider, IP address and geo-location data) may also be collected by us or GINGERSTIPS service providers to learn more about your use of the Sites.

GINGERSTIPS may collect additional information as described in this privacy policy through social media and other websites that display authorized GINGERSTIPS branding. GINGERSTIPS reserves the right to collect information from you through commercially available sources such as public databases, data aggregators or other commercially available means and may cross

reference or combine information and use it as described here.

GINGERSTIPS uses information collected from you for the following general purposes:

- To fulfill your requests for products and services and to answer any questions you may have about those requests.
- To improve our services, online stores and your shopping experience.
- To contact you, through periodic communications about GINGERSTIPS tools and resources, promotions, merchandise and services.
- To customize the advertising and content you see, conduct research, and provide anonymous reporting for internal use only.
- To analyze trends and statistics.
- To protect the integrity and security of the Sites and business.

COOKIES AND SIMILAR TECHNOLOGY

GINGERSTIPS may set and access GINGERSTIPS bits of code called “cookies” on your computer or mobile device. Cookies enhance the convenience and use of

www.Gingerstips.org by allowing us to recognize you as a previous user (eliminating the need to enter your personal information every visit), offer personalized web page content and information for your use, and otherwise facilitate your website experience. You may decline cookies by disabling them in your Internet or mobile browser. Disabling the cookies may affect some of the features of the Sites including online purchasing as we would no longer be able to track your order.

CONFIDENTIALITY AND SECURITY

Gingerstips.org does not rent, sell, or share personal information about you with other people or non-affiliated companies, except to provide products or services you have requested and when we have your permission. GINGERSTIPS will not send you unsolicited advertisements or solicitations without providing you the opportunity to decline to receive them; however, we reserve the right to send you certain communications such as service announcements, administrative messages and Purchase communications, that relate to or are part of products or services you have purchased or agreed to obtain from Gingerstips.org without offering you the opportunity to opt-out of receiving the communications.

As a general policy, GINGERSTIPS does not rent, sell or share personal information about you with other third parties. Exceptions to this policy include:

- Suppliers, Affiliates and Service Providers

GINGERSTIPS may provide your personal information to affiliated businesses, suppliers and service providers in connection with your use of the Sites. GINGERSTIPS requires all affiliated businesses, suppliers and service providers to agree to use your personal information only for the purpose for which it is provided to them, and to protect the privacy of your personal information in a manner that is consistent with this Policy.

- Legal Disclosure

When a government agency asserts its lawful authority to obtain information, issues a subpoena, warrant or another jurisdiction with authority to compel compliance, requests information, GINGERSTIPS may disclose your personal information to that agency.
